#### Martin County Alliance 1<sup>st</sup> Facade Grant Program: A Great Success!

The Martin County Alliance is proud to celebrate the success of its first-ever Facade Grant Program, which has received a fantastic response from the community. Thanks to a generous \$40,000 contribution from the Martin County Redevelopment Commission, the program was launched to enhance the downtown business districts in all three Martin County communities: the Town of Crane, the City of Loogootee, and the Town of Shoals.

The Facade Grant Program offered business owners a 1:1 match, with a maximum grant of \$4,000. This initiative was designed to help local businesses make aesthetic improvements to their storefronts—benefiting not only the individual businesses but also the overall appearance and vitality of our downtown areas.

These businesses will use the funds to make improvements that will collectively enhance the charm and appeal of our downtown districts. The initial \$40,000 investment has sparked a total of \$106,000 in planned improvements across the area.

Improvements are set to be completed by October 31st—stay tuned for updates as these exciting changes take shape! This initiative is just the beginning of many efforts to revitalize and strengthen Martin County's downtown areas.

These visual tools have been instrumental in building capacity and supporting fundraising efforts. MARTIN COUNTY ALLIANCE AWARDED \$10,000 TO SUPPORT LOOGOOTEE SENIOR CENTER RENOVATIONS

The Martin County Alliance for Economic Growth Inc. is proud to announce it has been awarded a \$10,000 grant from the Martin County Community Foundation to support enhancements at the Loogootee Senior Center. This initiative is a collaborative effort between the Martin County Alliance, the City of Loogootee, and the Martin County Council on Aging.

The Alliance secured the funding to improve the Senior Center facility, which is owned by the City of Loogootee and where programming is managed by the Council on Aging. With nearly 20% of Martin County's population aged 65 and older, this project represents a vital quality-of-life investment for the community's seniors.

Looking ahead, the Alliance hopes to deepen its partnership with the City and the Council on Aging by involving local high school students in Project-Based Learning (PBL) activities at the Senior Center.

PBL is an educational approach that encourages students to actively engage in real-world projects, addressing complex questions and challenges.


